**RESOLUTION NO. 2018-S044**

**WHEREAS**, the Administration Unit-Manpower & Facilities Administration requested the Bids and Awards Committee (BAC) through the Administration Unit-Office Services (delegated authority), for the small value procurement of Petroleum (Gasoline and Diesel) for PhilEXIM official service vehicles supply, with an approved budget for the contract (ABC) of Eight Hundred Forty Thousand Pesos (PhP840,000.00), inclusive of VAT and all other applicable government taxes;

**WHEREAS**, the requested procurement is under the approved Annual Procurement Plan (APP) for CY 2018 (updated) , viz:

**WHEREAS**, the Request for Quotation (RFQ) for the procurement of Petroleum (Gasoline and Diesel) for PhilEXIM official service vehicles supply were sent to the following suppliers:

- b. Oil Empire, Inc.
- c. Petron Philippines Corp.

**WHEREAS**, the Request for Quotation for the procurement of Petroleum (Gasoline and Diesel) for PhilEXIM official service vehicles supply was posted at the

TIDCORP and PhilGEPS websites and at conspicuous places within the premises of TIDCORP, for seventeen (17) calendar days;

**WHEREAS**, no quotations were received before the set deadline of 21 September 2018/ 2:00 p.m.;
