RESOLUTION NO. 2018- S065

WHEREAS, the Technology & Systems Department requested the Bids and Awards Committee (BAC) through the Administration Unit-Office Services (delegated authority), for the small value procurement for the Back-up Internet for CY 2018-2019 with an approved budget for the contract (ABC) of Two Hundred Ten Thousand Pesos (PhP210,000.00), inclusive of VAT and all other applicable government taxes;

WHEREAS, the requested procurement is under the approved Annual Procurement Plan (APP) for CY 2018 (updated) , viz:

WHEREAS, in order to promote economy and efficiency, alternative methods of procurement may be resorted to in accordance with Section 48.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 or the Government Procurement Reform Act, such as in this case;

WHEREAS, the item to be procured does not exceed the threshold prescribed in Section V.D.8.a.i of Annex H of the 2016 Revised IRR of RA No. 9184 and does not fall under shopping in Section 52;

WHEREAS, the Request for Quotation (RFQ) for the procurement for the Back-up Internet Subscription for CY 2018-2019 were sent to the following suppliers:

- a. Globe Telecoms
- b. Bayan Tel
- c. PT&T

WHEREAS, the Request for Quotation for the procurement for the Back-up Internet for CY 2018-2019 was posted at the PhilEXIM website and at conspicuous places within the premises of TIDCORP;

WHEREAS, the Request for Quotation for the procurement for the Back-up Internet for CY 2018-2019 was posted at the PhilGEPS website for six (6) calendar days and was viewed by the following suppliers:

- a. Advancekonek Corp.
- b. Now Corporation
- c. Converge Information & Communication Technology Solutions, Inc.

d. Three Lights Management & Consultancy Corporation

WHEREAS, only PT&T submitted a quotation before the set deadline of 12 November 2018/2:00 p.m.;

WHEREAS, the End-user, upon initial evaluation, recommended the bid of PT&T to be the Single Calculated Quotation;

WHEREAS, PT&T submitted the minimum documentary requirements under Annex H, Appendix A of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 per GPPB Resolution No. 21-2017 dated 30 May 2017;

WHEREAS, upon further verification, validation and ascertainment of the statements made and documents submitted by PT&T, the BAC found the bid of PT&T to be not compliant with Section 34.3.c in relation to the required financial capability requirement under Section 53 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 or the Government Procurement Reform Act;

WHEREAS, Section 35.1.c of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 provides that:

"The BAC shall declare the bidding a failure when:

All bids fail to comply with all the bid requirements or fail post-qualification, or in the case of Consulting Services, there is no successful negotiation."

NOW, THEREFORE, We, the Members of the Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is hereby **RESOLVED, via REFERENDUM**, to declare the failure of bidding for the procurement for the Back-up Internet for CY 2018-2019.
