



**BID BULLETIN NO. 1  
PROCUREMENT OF HEALTH CARE SERVICES OF PHILEXIM  
EMPLOYEES 2017-2018**

As discussed during the Pre-Bidding Conference for the Procurement of Health Care Services of Philexim Employees for CY 2017-2018 last March 9, 2017 and agreed upon by the Bids and Awards Committee of TIDCORP, the following are the amendments on the Terms of Reference, Bid Data Sheet and Instruction to Bidders:
