

CONTRACT AGREEMENT
(Security Services)

THIS AGREEMENT made on the _____ day of August 2018 between **TRADE AND INVESTMENT DEVELOPMENT CORPORATION OF THE PHILIPPINES**, also known as *Philippine Export-Import Credit Agency (PhileXIM)*, (hereinafter called "the Entity") of the one part, and **ARM CORPORATE SECURITY SERVICES, INC.** of 28 Gladiola Street, Roxas 4, Quezon City (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Procurement of Security Service** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Nine Hundred Forty One Thousand Six Hundred Forty Six & 06/100 Pesos (₱941,646.06)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (A) the signed Terms of Reference; and
 - (B) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The provisions of the General Conditions of Contract (GCC) in accordance with Republic Act No. 9184 *otherwise known as the Government Procurement Reform Act* shall apply suppletorily on matters not expressly covered by Section 2(A) or/and 2(B) of this Contract Agreement.
