INVITATION TO BID FOR
Procurement of Multi-Purpose Vehicle

1. The **Trade and Investment Development Corporation of the Philippines (TIDCORP)**, also known as **Philippine Export-Import Credit Agency (PhilEXIM)**, through the 2018 Corporate Operating Budget approved by the TIDCORP's Board of Directors³ intends to apply the sum of **One Million One Hundred Thousand Pesos (PhP 1,100,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Multi-Purpose Vehicle**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The TIDCORP, through its Bids and Awards Committee (BAC), now invites bids for Procurement of Multi-Purpose Vehicle that shall be delivered at TIDCORP's office premises located at 17th Floor, Citibank Tower, Citibank Plaza, Makati City.⁴ Delivery/completion of the Goods (including all incidental services shall be within twenty (20) days reckoned from the date indicated or specified in the Notice to Proceed (NTP) issued to the winning bidder. Bidders should have completed, within the last one (1) year from the date of submission and receipt of bids, a contract similar to the Project which is equivalent to fifty percent (50%) of the ABC for the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from TIDCORP and inspect the Bidding Documents at the address given below during **8:00 A.M. to 4:30 P.M., Mondays to Fridays**, except non-working holidays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 19, 2018 up to December 10, 2018** from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (PhP 5,000.00)**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The TIDCORP will hold a Pre-Bid Conference⁵ on November 27, 2018 at 10:30 am **TIDCORP, 17/F Citibank Tower, Citibank Plaza, Valero St, Makati City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **December 10, 2018 at 10:00 am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.


Bid opening shall be on **December 10, 2018, 10:30 am** at **TIDCORP's Boardroom 17/F Citibank Tower, Citibank Plaza, Valero St, Makati City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The TIDCORP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
